Subject: Important information regarding Merger ALSO Nederland B.V. to ALSO International B.V.

Dear partner,

In this letter we want to inform you about the legal merge of ALSO Nederland B.V. in to ALSO International B.V. Which means that ALSO Nederland B.V. will be the disappearing entity and ALSO International B.V. will be the receiving entity. Subsequently after this merger we will rename ALSO International B.V. into ALSO Nederland B.V.

“Everything stays better” is the motto for this transformation. The goal is to keep delivering more and better value to our vendors and customers.

Result of this merger is that the current (contractual) rights and obligations of ALSO International B.V. will remain unchanged and the current (contractual) rights and obligations of ALSO Nederland B.V. will be automatically legally transferred to ALSO International B.V. The merger will be notary executed on June 1st 2022. Your account and customer data will be transferred automatically, therefore no action is required from your side. Customers who have an account with both ALSO International B.V. and ALSO Nederland B.V. will be contacted by us personally.

We would like to explain what this means for you in terms of placing and delivering your orders and give you some suggestions on how to minimize the impact.

#### **Changes in delivery times**

- From Monday the 30th of May 17:00 hrs. till Thursday the 2nd of June 09:00 hrs. we will not be able to accept, process or ship orders.
- Orders placed on Monday the 30<sup>th</sup> May until 12:00 will be delivered on Thursday the 2<sup>nd</sup> June. Orders placed on Monday the 30<sup>th</sup> May after 12:00 will be delivered on Friday the 3<sup>rd</sup> June.
- From 09.00 on the 2<sup>nd</sup> June onwards we will take orders again and send them for delivery on the 3<sup>rd</sup> June.
- The ALSO Cloud Marketplace will stay available during this time, it will not experience downtime during this period.

We kindly ask you to take these changes in delivery times into account. This will allow you to be proactive and place your desired orders on time with us so that your stock level remains optimal during this period.

#### **Existing orders**

Back orders and other data such as ship-to-parties, vendor status, webshop accounts will be transferred by us. Do you use an EDI connections to place orders? If so, your EDI contact person will receive information from us.

#### **Adjust your administration**

In the appendix you can find all the administrative information which will be active as of the 1<sup>st</sup> of June. We kindly ask you to adjust all the details in your administration.
